Dr. Kotrba has authored Selective **Mutism: An Assessment and Intervention** Guide for Therapists, Educators, and Parents and Overcoming Selective Mutism: A Field Guide for Parents. She created and codirects Confident Kids Camp, a camp for children and teens with Selective Mutism that runs annually in Brighton Michigan (with offshoot camps in the metro DC area and Toronto, Canada). She also provides education to parents, school personnel, and professionals about Selective Mutism, offering informative and engaging webinars including Unlocking the Mystery of Selective Mutism.
