COURSE DESCRIPTION

Most assume depression will 'look' obvious; a student who is sad or stays to themselves or perhaps even one who cries incessantly. But the reality is that this mental health disorder can take many forms in a classroom from the class clown to the angsty teen to the stereotypical loner.

This session will cover the various behavioral symptoms that are required to have a diagnosis of depression, delve into the neuroscience of the disorder and then show how various evidence-based interventions, including those using the principles of Applied Behavior Analysis, relate back to those symptoms. We will highlight methods to find a student's motivation and harness those motives to gain momentum and meet goals during this complex period. Of course, ensuring we can do this in a school environment by school personnel and other important stakeholders is a hallmark of realistic evidence-based interventions.

R. Nicolle Carr, Ph.D., earned her doctorate in behavioral neuroscience/psychology from the University of Texas. Austin in 2005 and has been a Board-Certified Behavior Analyst since 2008. She is currently the Director of Clinic Services for an ABA company overseeing clinics across the state. Prior to that, she served 5 years as the Director of the Applied Behavior Analysis program at the University of Oklahoma. Most recently, she founded the Oklahoma state chapter under the ABAi. Dr. Carr served as the assistant clinical director at a residential program outside of Boston and as a consultant for a clinic in Western MA. Dr. Carr also served as the secretary of the Society for Behavioral Neuroscience and Comparative Psychology of the American Psychological Association and the Ethics Special Interest Group for the Association for Behavioral Analysis International. Her most recent accomplishment is publishing a textbook called Applied Behavior Analysis in Schools: Realistic Implementation of Evidence-Based Interventions by Teachers.
